The Laten Legacy Endowment

The desire to continue fulfilling God's call on one's life beyond the years of that life is desirable. It can be seen as providing a bridge that connects the present with the future. Perry and Dona Laten of Fremont, Nebraska, were such bridge builders. This couple, who were married in 1966, put their Christian faith into action using their God-given skills and interests throughout their 53 years together. Moreover, to ensure that their dedication to support ministries and mission did not end at the close of their earthly journeys, they established an endowment with the *American Baptist Foundation (ABF)*.

Through this decision, the Latens ensured that future outreach would be strengthened by the *American Baptist Home Mission Societies (ABHMS), International Ministries (IM), American Baptist Churches of Nebraska*, and the congregation where they were members.

The endowment reflects how they used their time in building God's kingdom. For instance, Dona, who had earned a Bachelor of Science degree in nursing from Omaha University in 1967, became a volunteer camp



nurse for a children's summer camp at the Moses Merrill Camp and Conference Center. At the same time Perry performed any needed building and repair projects there using his carpentry skills.



As members of the First Baptist Church of Fremont, they participated at a high level in its worship services and ministries. Included among Dona's many activities were her being a faithful choir member, active in the women's group and a Bible study and prayer group, and being the Sunday school superintendent. Perry, who was a source of wisdom and support for many congregants, was an integral part of the men's group, a member of the trustee board, and taught Sunday school—first for youth and later as he got older, for adults. One of those adult attendees says,

"He could explain the Bible in laymen's terms and had vast biblical knowledge that he shared as a supplement to the quarterlies. He taught right up until the time when he was no longer physically able to do so."

The Latens deeply believed in the urgency and importance of helping others come to experience the salvation in Christ that they knew. This focus on a future home in heaven was demonstrated by their desire to see young people grow in their faith. That aspiration went beyond teaching and personal encouragement to their once taking a group to the American Baptist National Youth Conference in Colorado.



A home for peoples' earthly future was also a priority for them. It is said that the Latens worked on every Habitat for Humanity house that was built in the Fremont area. Their dedication for mission beyond their locality is illustrated by what Perry once said to a friend when they were talking about a possible second trip to the Holy Land:

"Perry stated that he would like to go again. I asked him why he didn't go. He said something like 'If I do, some missionaries will not have that money that I would have spent on that trip to do their work."

At each of their memorial services—Perry's in 2020 and Dona's a year and a-half later—members of their church celebrated the Latens' faithful journey with Christ and each other. Their pastor, Rev. Richard Crooks, observed:

"Their devotion to one another was striking. You can hardly talk about one without mentioning the other. What did Dona like to do? She liked to be with Perry. Whether it was fishing together in Minnesota, tending the flowers and vegetables in their yard or over at the community garden space, and so much more, they were always together. Can't you still see the admiration and fondness in their eyes as they gazed at one another?"

One of Perry's hobbies at home was to use his woodworking skills to build bridges—musical bridges. Actually, more than that. He was known for his refurbishing and refinishing whole violins, even though he didn't play one. He never charged the owners for his labors. And there are reports that when he discovered some used violins, he would purchase them, beautifully restore them, and then donate them to a school or directly give them to excited children. But his greatest labor at home came when Dona began developing Alzheimer's. Perry let it be known that it was his job, not anyone else's, to take care of her because of their wedding vows.





Although both Perry and Dona sought to serve God without drawing attention to themselves, their faithful dedication to minister made that difficult. In 1997, for example, Perry was named the Layman of the Year by the American Baptist Men of Nebraska.

Perry was employed for 35 years by the George A. Hormel Company as a hog buyer. Seeing the business on a first-hand basis, he regularly bought stock in the company, which helped create a legacy. As the Latens prayerfully contemplated how they could build a bridge to provide for future mission work using their financial resources, they had contact with the American Baptist Foundation (ABF). Perry particularly spoke on many occasions with Paul Weers, ABF's representative in their area. Paul states:

"I saw Perry often at various American Baptist regional meetings and in their home. I found him to be an astute man with a great sense of humor. His warm personality was especially revealed when he boasted about the Nebraska Cornhuskers college football team. His dedication to them was exceeded only by his commitment to Christ, to his wife, and to ensuring their resources would support mission outreach for decades to come. That's why they rejoiced when they signed the papers that created the Dona and Perry Laten Legacy Endowment with the American Baptist Foundation."

The source of the Latens' inspiration can best be summarized by a poem, *The Bridge Builder*, by Will Allen Dromgoole, that Perry quoted from memory on occasion and which describes how they lived their lives:



Building a Bridge for the Future

An old man, going a lone highway, Came, at the evening, cold and gray, To a chasm, vast, and deep, and wide, Through which was flowing a sullen tide.

The old man crossed in the twilight dim;
The sullen stream had no fear for him;
But he turned, when safe on the other side,
And built a bridge to span the tide.

"Old man," said a fellow pilgrim, near,
"You are wasting strength with building here;
Your journey will end with the ending day;
You never again will pass this way;
You've crossed the chasm, deep and wide—
Why build you this bridge at the evening tide?"

The builder lifted his old gray head:
"Good friend, in the path I have come," he said,
"There followeth after me today,
A youth, whose feet must pass this way.

This chasm, that has been naught to me,
To that fair-haired youth may a pitfall be.
He, too, must cross in the twilight dim;
Good friend, I am building this bridge for him."

Charitable IRA Rollover

Congress made permanent the law that allows people age 70½ or older who own an IRA to make gifts directly from their IRA to charity. For many people, this is the best tax-wise way to give. An IRA rollover gift will not be included in your taxable income and may qualify for your required minimum distribution.

Gifts of Stock

An outright gift of stock or other appreciated marketable securities is an excellent way to contribute to ministry while receiving attractive tax benefits. Stocks can also be used to create an income paying gift, such as a CGA or charitable trust.

This option works best for individuals who:

- · Have investments that have grown over time
- Are concerned with paying capital gain taxes
