
## Giving Your Testimony through a Legacy Plan

Before Jesus ascended into heaven he said to his followers,

"You shall be my witnesses...." (Acts 1:8)

To be a witness of God's love revealed in Christ is like giving a testimony in court—it reflects the beliefs and feelings of the one on the stand. **The C. Austin Earle Family Legacy Endowment**, managed by the *American Baptist Foundation*, is such a testimony.

When God called the Earle family to be good stewards of all He gave them, they listened! Beginning with C. Austin Earle—an American Baptist pastor emeritus of Martin's Pond Union Baptist Church in North Reading, Massachusetts, and Army Chaplain in World War II—Earle family members have given their testimony through their generosity. They also learned the importance of legacy giving when their father set up endowments for his church and for Gordon College.



Following in his footsteps, his son, Ralph, has dedicated his life to honoring God through good stewardship, using his resources to help others. He graduated from Northeastern University in 1966 with a degree in mathematics and physics. He served as an officer in the U.S. Army, including a year in Korea during the time when experimental satellite communications were being introduced. Ralph was one of only seven authorized personnel to have access codes for them. Then after a remarkable career with Teledyne, where he had top secret clearance as a Senior Systems Analyst, he retired. That reveals the "professional" Ralph.





The "personal" Ralph is even more impressive. He is a soft-spoken, humble man who describes himself as "using the talents that God has given me, honoring God with my life, and being a good steward." He has demonstrated these qualities by devoting his time, talent, and treasure as Christ would have him do so. He especially shares these gifts with his church, where his father was once pastor and where he leads in worship when needed and is always a teacher by word and example. Ralph loves his church and supports it generously, including making it one of the beneficiaries of several planned gifts managed by the American Baptist Foundation. He liberally supports the regional ministries of the American Baptist Churches of Massachusetts with both annual and planned gifts. He especially appreciates the region's School of Ministry program because he believes in the importance of training leaders in discipleship.

Ralph has shared his gift of generosity by volunteering his time as well, no matter where he has lived. When he lived in Alabama, he conducted nursing home worship services every Sunday, serving communion and praying with the residents. When one of the church's members required long-term care, Ralph visited her almost daily for more than two years. When he returned to Massachusetts, he collected day-old bread from a bakery and delivered it to the North Reading Food Pantry for years.

pon his decision to sell his home in Alabama and move to Massachusetts to help his ailing brother, it came to Ralph's attention that there was a

family of foreign nationals who needed a house. But they had not established a good credit rating. Ralph sold his home to them and held the mortgage, which would help them build their credit rating.

Ralph has taken "service and stewardship" very seriously; they are an important part of his testimony. He is committed to leaving a legacy as his father did, by creating the C. Austin Earle Family Legacy Endowment.

In the words of Susan, his sister in-law,

"Ralph has touched so many lives with compassion and generosity. I can't begin to count the ways, but I do know his favorite Bible verse from Matthew 6:21, which he shares with us always."

This verse certainly helps explain the testimony he has given through creating his legacy plan:

"For where your treasure is, there your heart will be also."

### Legacy Giving

### Charitable IRA Rollover

Congress made permanent the law that allows people age 70½ or older who own an IRA to make gifts directly from their IRA to charity. For many people, this is the best tax-wise way to give. An IRA rollover gift will not be included in your taxable income and may qualify for your required minimum distribution.

#### **Gifts of Stock**

An outright gift of stock or other appreciated marketable securities is an excellent way to contribute to ministry while receiving attractive tax benefits. Stocks can also be used to create an income paying gift, such as a CGA or charitable trust.

This option works best for individuals who:

- Have investments that have grown over time
- Are concerned with paying capital gain taxes

There are many planned giving options available to you. Whether it be a gift of life insurance, a bequest through your will, or a gift of real estate, ABF can work with you and your advisors to establish a gift plan that works best for you, your loved ones and the ministries you hold dear.

For your convenience, ABF will work with your financial advisor or institution to facilitate your desired gift.
